President's Message

I am sure that most all of you have seen the orange colored tumbler that the raffle tickets are placed into. Well at least it originally was orange. I think it has faded over the years. Anyway, Steven Breitbart carried it over to me during my 12:30 PM SIG to show me that the plastic sliding door part of the tumbler had broken. Looking at the rest of the clear plastic, it might be Plexiglas or something else I'm not sure, all of it had craze marks or micro-breaks, whatever it should be called, throughout. Considering that the tumbler is, I believe, pushing 30 years old, it is not really surprising that the plastic is dying. Even if it is only 25 years old, it has been used over 300 times. I do not remember who made it, but clearly they did a pretty good job of constructing it. On the plus side, Steven said that he would take it home and refurbish it with some new plastic. So, our familiar icon of the prize drawing should be around for quite a few more years.

Thinking about the dying plastic in the raffle tumbler reminded me that we have a number of people who no longer participate in club activities. Mainly, because they died of old age. A lot of them were in their prime, somewhere between 30 and 50 years old, when they joined the club. But 25 to 35 years later, you're no longer a spring chicken. As happens frequently, that subject, and what to do about it, was brought up, yet again, at the last Board meeting. The inability of the club to attract younger members has been an ongoing concern for at least 15 years. A suggestion was made by a relatively new member of the Board of Directors that we should try to get students from Chapman University to join the club. The response was, been there, done that, several times in several different ways without success.

Another member suggested that perhaps the club just wasn't relevant to the mainstream computing requirements and interests of today. That the Chapman University students are somehow doing computer stuff that is different than what we do in the club. That between the Internet and their friends, they don't need what the club has to offer. And to a large extent, that very well may be true of Chapman's students. And, they frequently have a pretty demanding schedule that requires using the weekend to catch up, and maybe to use it for a little bit of play. But, what may be true for the staff and students, certainly isn't true for the population at large. To back up that contention, I would point out that Leo Laporte, The Tech Guy, is syndicated on 100 radio stations in the United States. His forte is addressing the computer/tech problems that his listeners call in about. The same stuff the club's motto "Friends Helping Friends" refers to. The local outlet is radio station KFI, AM 640, on the weekend. I don't know how many people listen to him on KFI, much less the other 99 stations, but it's certainly a large enough number to keep the advertisers happy, and in total that has to be huge number. So there is no lack of people out there that could benefit from what the club offers.

So if you have a son or a daughter or a neighbor or relative that is in that "younger" category, see if they would contribute some understanding. Ask them if they would be interested in joining the computer club in order to obtain computer help, and if not, why not. And while you are at it, ask them what kind of subjects would interest them if they were available at the club meeting. I would appreciate it if you would then call or e-mail me with what you found out. Thanks, Jim.

Save Your Parking Permits!

To offset the cost of parking in the **Lastinger Underground Parking Structure**, the NOCCC Board approved a motion to give each member two NOCCC General Drawing raffle tickets in exchange for the Lastinger-parking permit. Turn the bottom-half “receipt” part of your permit to the Rafflemeister on the same day or hold it until the next meeting. **Gerry Resch, the Raffle Leader, will exchange it for two raffle tickets.**

The reason for this is that the NOCCC Board has found that some people are not attending meetings or not renewing their memberships because of the parking situation. Chapman University has allowed us to park in the Lastinger Parking Structure under Wilson Field for only \$2 for the whole day of our meeting; normally \$2 is good for only two hours. The advantages of parking there are clear; you don’t have to drive around looking for a legal spot (remember, don’t park on the private home side of the street), the car doesn’t get hot and you don’t have to parallel park. There is even an elevator available to get down to the parking area.

Consignment

The NOCCC Consignment Table in the lobby of Irvine Hall will not be available during the March 2012 meeting. It is open on even months, the same as the E-Waste collection.

For your information:

- 1) Only current members can place items for sale, but non-members are welcome to purchase items from the table. This is a great place to get some money for your surplus computer items, and help the NOCCC at the same time.
- 2) The consignment table operates on a 90/10% basis — with the owner getting 90%, and the Club treasury 10%.
- 3) **You can fill out a Consignment Table User List and item tags at the table:**
The user list and each tag must contain:
 - a) Seller's name
 - b) Seller's NOCCC membership number
 - c) Item name and description
 - d) Item asking price
- 4) The seller may pick up all items and/or money at any time, but **no later than 2 p.m. on the day of sale.** Any items and/or money not picked up by 2 p.m. will become the property of NOCCC and will be subject to disposal at the Club's discretion. The club has no storage room available for unsold items
- 5) NOCCC is NOT RESPONSIBLE in any way for items bought and/or sold at the Consignment Table. Each item is placed and sold on an AS-IS BASIS.

E-Waste Collection

California disposal laws have made it illegal to put monitors and computers in the regular trash. **Omni Technics, Inc.** will be at our regular meetings to collect E-Waste on even months, so save your "junk until April.

Displaying the AutoShapes Menu

If you have used Word for any length of time, chances are pretty good that you are already familiar with AutoShapes and how to use them in your document. If you have quite a few AutoShapes to insert in a document, you may find it handy to work with a floating AutoShapes menu instead of using the AutoShapes option on the Drawing toolbar. There are two ways you can display the floating AutoShapes menu. The first involves the use of the Drawing toolbar to get started:

1. Display the Drawing toolbar. (Click on the Drawing option on the Standard toolbar.)
2. Click on the AutoShapes option on the Drawing toolbar. The AutoShapes menu appears.
3. Position the mouse pointer over the bar at the top of the AutoShapes menu.
4. Click and drag the AutoShapes menu away from the Drawing toolbar.
5. Release the mouse button. You now have a floating AutoShapes menu.

The other method of displaying the floating AutoShapes menu is even a bit simpler:

1. Choose Picture from the Insert menu. Word displays a submenu.
2. Choose AutoShapes from the submenu. Word displays both the Drawing toolbar and the floating AutoShapes menu.

Understanding Frames and Text Boxes

If you are a relatively new user of Word, you may not be familiar with the term *frame*. Prior to Word 95, the only way to place boxed text in a document, independent of the main document text, was to use a frame. In Word 97, Microsoft made the switch and focused almost exclusively on text boxes. In modern versions of Word, if you want to insert a frame, you need to either customize your toolbars or go through a rather convoluted process. This is described in a previous issue of *WordTips*.

The relationship between frames and text boxes may be confusing to some people. Why, for instance, should one be used in preference to the other? If text boxes are the latest-and-greatest thing, then why didn't Microsoft simply make frames more robust rather than come out with text boxes in addition to frames?

According to Microsoft sources, even though frames continue to be available in the latest versions of Word, in most cases you should use a text box in preference to a frame. Text boxes provide nearly all the advantages of frames, along with many additional advantages. For example, text boxes allow you to do the following, which cannot be done directly with frames:

- Create links that allow text to flow from one text box to another.
- Create watermarks.
- Use most of the formatting options on the Drawing toolbar, including 3-D effects, shadows, border styles, colors, fills, and backgrounds.
- Select from a greater variety of text-wrapping options.
- Change the orientation of text within a text box.
- Group text boxes together and collectively change their alignment or distribution.

This is not to say that text boxes are suitable for all uses. Indeed, text boxes cannot handle some Word features, which are available in frames. You should use frames if you want to use text that contains the following:

- Comments (annotations).
- Footnotes.
- Some fields, such as AutoNum, AutoNumLgl, AutoNumOut, TC, TOC, RD, XE, TA, and TOA.

The upshot of all this is that you need to carefully consider how you will be using your frames or text boxes in order to determine which is the best for you. If you are still in doubt, you can always start with a text box and later convert it to a frame, if you discover you can't do what you want.

Automatically Saving Changes to Defaults

Many configuration changes that you make to Word are stored in a special template called Normal.dot. This template is used to help create new, blank documents and to define some of the system-wide settings used by Word. As you make changes to these settings, Word marks Normal.dot as "dirty" so that it will be saved when you exit the program.

By default, Word saves Normal.dot without any notification to you. However, you may want notification. Why? In case there were some changes done without your explicit action—for instance, by running a macro. If you want Word to notify you when it is about to save Normal.dot, follow these steps:

1. Choose Options from the Tools menu. Word displays the Options dialog box.




Figure 1. The Save tab of the Options dialog box.

2. Make sure the Save tab is selected. (See Figure 1.)

3. Make sure the Prompt to Save Normal Template check box is selected.
4. Click on OK.

Creating a Numbered List

Numbered lists are used quite extensively in many types of documents. For instance, numbered lists are used extensively in *WordTips* to detail the steps that must be followed to implement a tip. Word makes it very easy to insert a numbered list into [your document](#). To do so, follow these steps:

1. Type your list, only pressing **Enter** at the end of each item in the list. If an item runs more than one line, do not press **Enter** at the end of each line (let the text wrap to the next line automatically).
2. Select all the items (paragraphs) in the list.
3. Click on the numbered list [tool](#) on the Formatting toolbar.

Quickly Displaying Formatting Specs

There may be times when you want to quickly determine what the formatting is that is applied to either a character or a paragraph. Word allows you to quickly view this information by following these steps if you are using Word 97 or Word 2000:

1. Press **Shift+F1** or choose What's This? from the Help menu. This causes the mouse pointer to change to an arrow with a question mark beside it.

2. Point to the character or paragraph in question and click the mouse button.

Word displays a "balloon" that looks like the dialog balloons used in some cartoons. The balloon contains detailed information about the formatting of the character you pointed to, as well as the paragraph in which the character appears. You now have two options:

- Click on a different character to see more formatting information.
- Press **Esc** to make the balloons go away and return the mouse pointer to normal.

If you are using Word 2002 or Word 2003, simply select some text or place the insertion point within a word. Press **Shift+F1** and the Reveal Formatting pane appears at the right side of the screen. This pane shows the formatting applied to the text you select in the main portion of the screen. When you are done reviewing the information in the Reveal Formatting pane, you can close it just as you would any other pane.

Moving Drawing Objects

Other issues of *WordTips* present different ways to create various objects using the Drawing [toolbar](#). If you want to change the positioning of these objects once they are placed in your document, you can do so in this manner:




Figure 2. A selected drawing object has handles around it.

1. Using the mouse, point to the shape you want to move, and click on it. Word places small square boxes called *handles* around the shape. (See Figure 2.)

2. Using the mouse, point to the object. The mouse pointer should turn into a four-headed arrow.
3. Click and hold down the mouse button. **Drag** the object to the position desired.
4. Release the mouse button.

Unwanted Data Changes

Have you ever been typing data into a **worksheet**, only to look back and find that Excel had made changes to words or letters you entered. For instance, you may have a client named Hempstead-Gorton Enterprises, and you enter their initials into a cell as HGE. When you press the space bar or move to another cell, Excel changes the initials to HE.

This is one of those cases where Excel is second-guessing you and is doing a poor job of it. What is happening is that AutoCorrect is kicking into play, and sees HGE as a common typing error. Thinking that you meant to type "he," AutoCorrect makes the change for you.

If such unwanted changes are giving you the fits, you can follow these steps to correct the problem:

1. Choose AutoCorrect Options from the Tools menu. Excel displays the AutoCorrect tab of the AutoCorrect dialog box. (See Figure 3.)



Figure 3. The AutoCorrect tab of the AutoCorrect dialog box.

2. At the bottom of the dialog box you see a list of AutoCorrect entries. Scroll through the list and select the one that is giving you problems. For instance, if you don't want "hge" corrected to "he," then locate and select the entry that has "hge" on the left and "he" on the right.

3. Click **Delete**.
4. If there are other entries you need to remove, repeat steps 2 and 3 for each of them.
5. Click **OK** to dismiss the AutoCorrect dialog box.

Now you can type away without Excel incorrectly changing your acronym.

Fixing the Decimal Point

Most **electronic** calculators have an option that allows you to specify a fixed location for a decimal point. This comes in real handy when you are working with dollars and cents, for instances. With the decimal point fixed at two places, you can enter "213" and have the calculator translate it as "2.13". Likewise, if you enter "2", the calculator translates it as "0.02".

Excel has a feature that allows you to do the same thing. To fix the number of decimal places assumed when inputting **information**, follow these steps if you are using Excel 2007:

1. Click the Office button and then click Excel Options. Excel displays the Excel Options dialog box.
2. At the left of the dialog box click **Advanced**.




Figure 4. The advanced options of the Excel Options dialog box.

3. Under **Editing Options**, make sure that the check box for "Automatically Insert a Decimal Point" is selected. (See Figure 4.)

4. Using the Places control, specify how many decimal places Excel should assume.
5. Click the **OK** button.

If you are using an older version of Excel, follow these steps instead:

1. Choose **Options** from the Tools menu. Excel displays the Options dialog box.




Figure 5. The Edit tab of the Options dialog box.

2. Make sure the **Edit** tab is selected. (See Figure 5.)

3. Make sure the Fixed Decimal check box is selected.
4. Using the Places control, specify how many decimal places Excel should assume.
5. Click OK.

Tombstone Date Math

Robert loves to work on genealogy. Sometimes when he finds an older cemetery, instead of the birth and death dates being visible on a tombstone, just one date is visible and an age. For example, "born: Jan 18, 1801, died 81 yrs, 11 mths, 17 days" or "age: 93 yrs, 8 mths, 22 days, died March 18, 1901." Robert is wondering if there is any way to calculate the missing date to the day.

There is a way to do this, but it doesn't involve the use of regular worksheet functions. While Excel includes a rich assortment of worksheet functions that allow you to manipulate dates, the "basis date" for Excel is January 1, 1901; this is the date from which all dates are calculated. (You can change the basis date, but only by three years, to 1904. This capability is provided for compatibility with Excel on the Mac.) This means that older dates—such as those you would find in the cemetery for genealogy purposes—can't be directly calculated in Excel.

Fortunately, VBA doesn't have this limitation. This means that you can easily create a user-defined function (a macro) that will do the math for you. Start by placing the starting date (either birth or death date) in cell B1. Then, in cells B2:B4 enter the number of years, months, and days by which you want to adjust the starting date. Thus, if B1 contains a birth date, then cells B2:B4 should be positive (you want to add them to the starting date). If B1 contains a death date, then B2:B4 should be negative (you want to subtract them from the starting date).

Then, create this macro:

```
Function FindDate(Start As Date, iYrs As Integer, _
    iMths As Integer, iDays As Integer)
```

```
Application.Volatile
```

```
Dim D As Date
```

```
D = DateAdd("yyyy", iYrs, Start)
```

```
D = DateAdd("m", iMths, D)
```

```
D = DateAdd("d", iDays, D)
```

```
FindDate = Format(D, "m/d/yyyy")
```

```
End Function
```

In whatever cell you want to display the calculated date you can enter the following formula:

```
=FindDate(B1,B2,B3,B4)
```

The result of the function is a formatted date that represents the start date adjusted by the years, months, and days you specify. So if cell B1 contains 1/18/1801, cell B2 contains 81, cell B3 contains 11, and cell B4 contains 17, then the function will return 1/4/1883. Similarly, if cell B1 contains 3/18/1901, cell B2 contains -93, cell B3 contains -8, and cell B4 contains -22, then the result returned will be 6/26/1807.

Selective Summing

Excel contains a built-in function that allows you to easily specify which values should be summed from a column. This function, SUMIF, is used in the following manner:

```
=SUMIF(Testrange,Test,Sumrange)
```

In this usage, SUMIF uses three arguments. The first is the range of cells to be tested, the second is the test to use, and the third is the cells from which the sums are to be pulled. For instance, let's say that the cells in B2 through B27 contained days of the week (Monday, Tuesday, etc.), and that cells C2 through C27 contained the gross sales generated on those days. If you wanted to only get a sum for the sales on Mondays, you could use the following formula, perhaps in cell C28:

```
=SUMIF(B2:B27,"Monday",C2:C27)
```

This examines B2 through B27 and checks if the cell contains the text "Monday." If it does, then the corresponding cell is selected from C2 through C27 and added to the sum.

If you wanted to quickly pull sales totals for different days, you could modify the above scenario just a bit. All you would need to do is place the day on which you want to sum in cell B28. Then, in cell C28 you would place the following formula:


```
=SUMIF(B2:B27,B28,C2:C27)
```

Now the test for SUMIF is taken from cell B28. Thus, if B28 contains "Monday," then the sum will reflect the total of Monday's sales. If it contains "Wednesday," then Wednesday's sales will be summed, and so forth.



Microsoft Excel 2010 Bible

Part I: Getting Started with Excel. This part consists of nine chapters that provide background about Excel. These are considered required reading for newcomers, but even experienced users will probably find some new information here.

Chapter 1, pages 6-8 provide a review of the workbook screen and a list and description of all of the features in Excel. Be sure to have these pages open when you execute the program. This will help you become familiar with the screen, particularly if you are upgrading from a version prior to Excel 2007. Chapter 1 provides a good overview of the ribbon and features contained in it. I recommend you scan these pages even if you are familiar with the ribbon and its features, and especially if you are not familiar with the ribbon (pre-2007 users). Work the examples from the CD as you go through the pages to see how easy the new features are to work with.

Chapter 2 provides an excellent overview of the TYPES of data that can be entered into a workbook. You’ll want to review this chapter even if you are an experienced user of Excel. One rarely uses all types of data on a regular enough basis to become or remain familiar with the characteristics of various data types so this chapter would be a good one to ‘play’ with. Note the number limitation comment on page 31. Unless you are entering astronomical or nano values, you’re not going to have any problem with Excel’s number limitation. Another useful bit of knowledge is how to enter large amounts of text and get it all to display. For this, see page 32. Ever work with fractions? Not decimals, but real fractions. Check out page 40 for working with fractions (i.e. 6 1/8, not 6.125). This chapter continues

with other useful data formats and tips on using them. Spending time with this chapter will be a good investment.

Chapters 3 and 4 provide an excellent overview of essential worksheet operations and working with cells and ranges. Try out some of these operations if you haven’t used them before or if you haven’t used them for a long time. They just keep adding new features and functions. You may find the solution to doing something you wished you could do but didn’t know was in Excel. Tables are used in many applications so you’ll want to spend some time in chapter 5 to get familiar with the many features available to make your table(s) easier to use and more productive in your application. Want your work to stand out? Chapter 6 will show you how to make your workbook so original you might not recognize it when you open it the next time. Chapter 7 reveals the file types that are used in Excel. A nice feature in 2010 is the INFO feature (p. 149). Delete the wrong file? Didn’t save the changes? Click on File => Info and breathe easier. Pages 149 – 156 explain the many options in this feature. And be sure to read the File Compatibility feature on 157. There are many file formats in Excel. Be sure you specify the format that is best for your application, especially if you want to share the workbook with an older version of Excel.

Excel has been called the ‘Swiss Army knife’ of office productivity software because it is so useful for so many applications. Take a look at the templates in chapter 8. You would have to have a very special need not to find a template that will get you up and processing in a short time. But just in case you have that unique requirement, this chapter will guide you in making a template to fill that need.

Part II: Working with Formulas and Functions. These eight chapters cover everything that you need to know to become proficient with performing calculations in Excel. Calculations are really why Excel was created so review chapter 10, and especially regarding the more than 50 new functions in 2010. Wow! Chapters 10 – 17 are almost required reading. If you’re using Excel, you have to be familiar with formulas and functions and working with dates and times. Don’t rush through these chapters. Use the programs from the disk to work with the actual formulas and functions. Note the new feature on page 393 that eliminates the need for an array formula.

Part III: Creating Charts and Graphics. These five chapters (18 – 22) describe how to create effective charts. In addition, there’s a chapter on the conditional formatting visualization features, and a chapter on the new Sparkline graphics. Load the example programs for these chapters before you start. You’ll have fun playing with the many chart programs and discovering wonderful ways to present your data in eye-catching visualizations. How to make your chart stand out is covered in chapter 19. Charts are the best way to make statistical data come alive so spend some time in chapter 20 on visualizing the data with conditional formatting. New in 2010 are Sparkline graphics in chapter 21. These are single cell graphics that are displayed along side of data displayed in ranges. Need more

tools to make your graphs outstanding? Then check out inserting pictures and SmartArt in chapter 22.

Part IV: Using Advanced Excel Features. These 10 chapters (23 – 32) deal with topics that are considered advanced. However, beginning and intermediate users may find this information useful as well. If you're new to Excel 2007/2010 I recommend reading about the Quick Access Toolbar in chapter 23. This can save you lots of time in searching for a function, particularly if you are new to using the ribbon. And new in 2010 is the ability to customize the ribbon. Check this out to see if you can see how to put your usual functions in an easier to access location. I like the ability provided to create custom number formats (chapter 24). This can make data entry a lot easier as well as customizing the display of numbers. Another function to help with data entry is Excel's data validation (chapter 25). This can really help ensure data entry accuracy. Have lots of detail levels of data in your workbook? All that detail is wonderful when you need a specific value but sometimes it is hard to find a number in all of those columns and rows of numbers. Check out using worksheet outlines in chapter 26. Wow. Outlines can compress the presentation of large ranges of data into simple table-like displays.

If your application has lots of data at various levels, say in many departments or groups, it can be a problem gathering the data to form summary information. In this case, look at linking and consolidating worksheets in chapter 27. This is a powerful advanced method of getting data in diverse workbooks or worksheets into a single worksheet without altering the original data in the separate workbooks or worksheets.

The Internet has become the way to let the world communicate so if your application has need to share info with other locations, be sure to get into chapter 28. In this chapter you'll be exposed to how to make your workbooks available for viewing over the Internet. It's technical but do work with the sample files from the CD and see if this is a feature that will open a door for an exciting way to share your data to those connected to your network. OK, you don't need the Internet but you would like to share data with other Microsoft Office Applications, like, say, Word or PowerPoint. Chapter 29 will show you how this can be done. Getting excited? There's more. If you have a network (at home or at work) you can share Excel among members in the whole group. At least, review chapter 30. It might not be as hard to do as you think, though it does require some planning. That can be instructive, too.

So you've got your Excel app working wonders, everything's on the computer. OK, it's probably a good time to consider protecting it, particularly if you are using a network. Read chapter 31 at take its advice to heart. Protection is not just to get others out of your program; it's also to save you from that 'Oops!' moment when you click the wrong button.

Part V: Analyzing Data with Excel. These six chapters focus on data analysis. Users of all levels will find these chapters useful. Although an Excel workbook can hold LOTS of data, sometimes the data can exceed the capacity of the system, or maybe the data is just located and maintained in a different system using another data storage method. If that's your case, chapter 33 presents getting data from files outside of Excel,

particularly other apps in the MS Office set of programs. I personally prefer to store and work with data in Access databases so being able to access those Access tables without converting them is really useful. And if that external database is really large, well just use the Query Wizard to select a subset of the data.

Why use Excel at all? Because it's the best tool for analyzing large sets of numerical data when you use Pivot tables. These tables also work with non-numerical data also, so be sure to see if this is the tool to solve your problem (or at least to make it easier). Other data analyzing tools are What-If Analysis, Goal Seeking, and Solver (which may be more power than you need but that's better than not having enough power).

Add-ins in the Analysis ToolPak provide powerful tools to enable you to perform advanced analytical work on your data. Generally, these tools are for non-business users but I recommend you at least scan chapter 38 and see if the tools in the ToolPak might be useful in your work, especially if your work involves heavy statistical analysis.

Part VI: Programming Excel with VBA. These seven chapters are for those who want to customize Excel for their own use or who are designing workbooks or add-ins that are to be used by others. It covers recording macros and VBA programming and then covers UserForms, add-ins, and events.


Macros are an easy way to automate repetitive operations. Capture the keystrokes while you perform the operation, store them as a macro, and thereafter, just execute the macro every time that operation needs to be performed. This is a great way to perform repetitive functions. If you are more technically inclined and want to perform some unique functions that Excel doesn't provide, then you're going to want to dive into Visual Basic for Applications (VBA) in chapters 39 – 44. I use VBA in many of my applications where I want the application to be unique in some operation. I particularly like to make Userforms to simplify the data entry function. While working in these chapters, be sure to load the sample programs from the CD and open them in the VB Editor so you can see the code in them. This will help you more quickly see how to create your own code. What's included in these chapters is very useful. However, to really get deeper into VBA you'll want to purchase another text that is specifically written for VBA. I recommend that you first work with these chapters and the sample programs from the CD before investing in a more technical book on the topic. Now, when you create a neat macro or VBA routine and would like to use it in other Excel workbooks, don't re-code it: save it as an Add-in that can be accessed by any other Excel workbook. This is covered in chapter 45 on creating custom Add-ins.

Appendices. There are four appendices that cover Excel worksheet functions, the contents of the book's CD-ROM, other Excel resources, and Excel shortcut keys.

Companion CD. The examples and workbooks for all of the examples in the book are available on the CD. Especially nice is an electronic version of this book on the CD. It's a searchable PDF file that makes referencing the material possible anytime you are on the computer. No need to take along the printed copy of the book.

Snagit - Version 9

1.) Summary

Snagit is a screen-capture program primarily aimed at those individuals who are at the semi-pro level of graphics-editing and multi-media manipulations, and can be intimidating for those with only passing-interest in these subjects.

The program is extremely useful for screen capturing and editing of many types of image files (.jpg, .bmp, etc.), text files, and for capturing streaming video and web-based scrolling text. Any display you can see on your screen can be captured and automatically placed in the Snagit editor. Captured streaming Videos can be converted and saved as .AVI files.

Fundamentally, the program might be considered the combined 'Print Screen' and Microsoft 'Paint' program on steroids.

Program operation is quite complex and may require some head-scratching to figure things out, especially for exercising some of the more advanced features. (Editor's note: TechSmith offers lots of tutorials on their web site.)

To see a quick summary video showing how the various capture modes operate, you can download 'capture-mode-rebrand.exe' (MP-4 movie) from the www.techsmith.com/Snagit web site. A free test copy of the program is also available from that site, along with dozens of other application notes and videos.

I have exercised many of the program features and find that there are more capabilities than I personally may ever use. Those features I did exercise worked fine after some struggles to force them and myself to operate the right way.

There is cursory Documentation provided with the boxed program, and reasonable pull-down menu help during program operations. Access to their website may be needed to understand how to utilize the some of the more advanced applications.

There are upgrades to the 9.1 program, and I did not install them since I wanted to evaluate the boxed as-is program. A

revised (Version 10.0) program is also available for purchase, which may simplify or add some program operations.

2.) Installation

The program is installed using the CD provided, and is quoted to work on Win XP, XP Pro, 2000 and Vista. The activation code provided with the CD allowed smooth installation, and no problems were encountered.

System Requirements are: 100Mb hard drive space, Internet Explorer 6.0 or higher, 1.0 GHz processor (2.4 GHz recommended).

I installed and tested the program on three computers at home which use different versions of WIN XP and XP Pro, and each worked fine.

On installation, there are two Icons placed on the desktop (see Fig. 1), one of which runs the basic Snagit program and the other accesses the Snagit Editor.

3.) Program Operation

A.) Capture Profiles




Figure 2. SnagIt Main Menu

The main Snagit Menu shows various Profiles and Profile Settings (see Fig.2) that can be set up before capture. The top row of icons let you select portions of the screen display you want to capture such as Region, Window, Full Screen, or Scrolling Window (Web Page). The next row of Icons allows selection of other capture modes such as Text, Screen Video, and Web Page images. The bottom row of Icons provides for selection of Input, Output, Effects, and other special options.

B.) Screen Capture

To capture the screen display, you first place the image (eg. a .JPG photo or a text screen) on the screen display. You then minimize the display (to Desktop) and select the Snagit icon, which starts the Snagit program.




Figure 3. EDITOR Main Menu

After selecting a Snagit profile (eg. Window or Region, etc.), you hit the 'Capture' icon and the screen image is automatically placed into the Snagit EDITOR (see Fig. 3). Captured photo or text images appear along the lower left portion of the screen. Dozens of captured images can be placed in the EDITOR and will remain there for future editing until you delete them.

Snagit also uses the keyboard 'Print Screen' key directly to capture images. Whenever this key is hit, the captured screen image is sent directly into the Snagit Editor as in the above example.

A 'Timed Capture' feature is also available which allows screen capture at any future specified time. Time of capture can be set in either seconds (1-60) or future date and time. A seconds timer displays the countdown, and the user therefore has time to set up the desired screen display before capture.

C.) Snagit EDITOR

Figure 3 shows two captured .JPG images at the lower-left portion of the screen, and the center screen portion shows the image selected for editing.

The EDITOR allows many options for image manipulation, such as drawing all sorts of object shapes and sizes on the image. Images can be rotated, cut out, cropped, colored, cascaded, border effects added, and many more effects added.....too numerous to list here.

Selecting the lower right (Library) icon displays a list of all previously captured screens by date and time and allows Editor access to these items.

Edited images can be sent directly to an E-Mail, an FTP Server, or to programs such as Microsoft Word, Excel, Power Point, Notepad, WordPad, Adobe Paint Shop, etc. One thing I found was that Images could not be sent to Open Office (eg. Office Writer, etc.), and you must have Microsoft Office installed to use this feature.

After editing, images can be saved as files in eleven different formats, such as JPG, PNG, PDF, BMP, GIF, and other popular formats. Images can also be sent directly to a printer if desired.

D.) CAPTURING SCREEN VIDEO

To capture any video (or any screen action) and save as an .AVI file:

- In SnagIt select the 'RECORD SCREEN VIDEO' icon
- Hit the 'CAPTURE' icon
- Using the cursor, enclose the screen zone to be captured
- Select 'Start Capture' and the screen capture begins
- Hit the keyboard 'PRINT SCREEN' key to stop capture
- The captured video appears in the SnagIt EDITOR (lower left)

- Select a folder location on your hard drive and save as an .AVI file

The .AVI file can then be viewed using Windows Media Player

Using methods similar to the above, either streaming video from a web site, or display of keyboard and mouse activity can be captured and saved as an .AVI file. Later review of these files can provide valuable tutorial info.

E.) ADVANCED EDITOR FEATURES

There are many detailed features in the EDITOR (for more advanced users), which I did not exercise. Some of these include:

- Working with Vector Objects
- Saving Vector Objects in a .SNAG file format
- Using Quick Style Galleries
- Applying Effects to Multiple files
- Using Keywords and Flags to make searching easier

Overall, any features in this program I did exercise worked perfectly as advertised albeit some struggling on my part was needed.

4.) Conclusions

As discussed earlier, my overall impression of the SnagIt program operation is that it is not immediately simple to understand, but is very powerful once a little pounding is used to decipher things.

The passing-user who is simply capturing a screen now-and-then would probably be happy using 'PRINT SCREEN' and then the 'PAINT' program. Both of these features are already included in Windows XP program software. Some multiple-steps are needed, but minimal-editing and saving of edited images is provided.

The real horsepower of SnagIt is in the simple, automatic tie-in to the SnagIt EDITOR, along with features such as Video Capture and other selectable Capture Profiles.

SnagIt EDITOR interfaces to E-Mail and other programs such as Microsoft Office, Notepad, WordPad, Adobe Paint Shop, etc. are also noteworthy tools.

For the person who is moderately interested capturing stuff, I would think the SnagIt Program is worth the \$ investment to provide some graphical experience and general knowledge of the subject.

Main Meeting Report

Our speaker was supposed to be Garrett McAllister of New Horizons Computer Learning Centers. His presentation was supposed to cover Apple products such as the iPhone, the iPad, the iPod, and Apple computers.

However, Mr. McAllister notified us that he had another engagement in San Diego. We are fortunate that President Jim Sanders was available to “pinch-hit” (though using a baseball term on Super-Bowl Sunday may upset some people). The subject that he talked about is Google Docs. This is basically a cloud-based suite of programs that rivals most Office suites, with the addition of on-line storage, also called cloud storage. The functions available are: Document, Presentation, Spreadsheet, Form, Drawing, or Table (Beta).

Initially, Jim described that any use of the Internet, with any browser uses the cloud. The browser, a local terminal program transmits your info into the cloud – to the bank of computers out there where it needs to go. For example, when filling in a form on line, that information is in the cloud.

To use Google Docs you need a Google Gmail account. This account can be used for Gmail and any other Google entity, such as YouTube. Jim demonstrated setting up a Google account. But there are so many users; your desired login name may not be available. Google first checks to see if your chosen name is available.

For example, James Sanders and JWSanders were already used, but by eliminating the “e” in Sanders, it would have been allowed. Jim ultimately decided on something like XXXXXXX.NOCCC@gmail.com.

You also need to pick a security question or write your own question. You must fill in the birthday field. You can put in a false date if you are unwilling to reveal your true age. Just remember what you used and use it consistently. You also have to type a word in a CAPTCHA (Completely Automated Public Turing Test to Tell Computers and Humans Apart) box. Also, a second email address is required. Google will send out an email to that address; it contains a validation code to let you regain access your Gmail account if you forget or lose your password. This may be a relatively new feature; when I signed up about two years ago, the email I got had an address for Google support, nothing more.

One claim by Google is that they do a better job checking for spam. One way Google checks an email is to make sure the sender address is real and the email is from the same place; that is, the sender address has not been spoofed. Suspected spam messages are blocked. Jim checked his email server and found almost 500 spam emails that his email server automatically put in the trash folder. Jim never saw them in his Eudora inbox. Some code is now embedded in a legitimate email that shows

that the email actually originated at the particular server it claims to be from. However, this doesn’t stop all types of spam.

You are then shown a site with a video on Gmail and all its new features. Gmail has been redesigned to make it more intuitive, more versatile in how you can display the messages and improve readability. Searching is at the heart of Gmail.

Moving on to Google Docs. Starting with the Create button, you can choose: word processor, spreadsheet, presentation, drawing, form, table (beta).

The word processor is not as powerful as Microsoft Word, but it has all of the features of a modern word processor. You change font type, color and size, can make selected text bold or italics and change the background color. It also has justification control and spell check. However, when you look at the more complicated operations, Google Docs is not as powerful. For example, in a multi-chapter book, in which each chapter has footnotes, Word will update the footnotes if the chapter is moved; Google Docs will not. It also does not let you import and annotate photographs directly. You must modify and save your photographs and then import them. However you can upload an RTF document and you can export in several formats, including OpenOffice. One thing, it does continually save the document to the cloud – notification is shown above the document.

Huge numbers of templates have already been created for the word processor, the spreadsheet and the presentation programs in many different topics, which can be searched, selected and modified as needed. For the spreadsheet application, these are essentially small programs which take advantage of the spreadsheet’s capabilities. For example, for the spreadsheet application, many calculators and personal finance templates are available. Jim demonstrated using a loan calculation spreadsheet. The templates are also available in several languages.


Jim has a preference for programs that operate strictly from his computer, but he was impressed with the number of templates available. You can discard a document, which sends it to the trash folder, but you need to empty the trash.

What if I wanted to say “10 plus or minus 0.5” (10 ± 0.5)? I knew to get a \pm you type Alt+241 (or Alt+0177), but I could not find the plus or minus character in the insert special characters menu of Google Docs. I finally found the preferences section which allows users to enter their own special characters. The primary purpose of this article is to review the NOCCC Main Meeting, not do a review of Google Docs. But, I could not find a robust spell checker. However, the program will underline words it suspects are misspelled with red dots and give you suggestions when you right click on such an underlined word.

Microsoft has a similar suite of programs called Office 365. For small businesses, they charge \$6 per user per month. For larger businesses, they have plans starting at \$10 per user per month. The one criticism I saw in using Google Docs is that before you know it, you’ve got 10 tabs open and it seems that closing a tab is the only ways of stopping work on a document; there are no Close or Exit buttons.


Advanced Digital Photography

Last Month


Circumstances beyond my control prevented demonstrating auto focus with moving objects.

Instead, we had some random access, discussed the power of modern camera strobes and did another demonstration of the combined power & ease of use of Layer Masks in Adobe Photoshop.



I recently found some old photos taken with my new (at the time) Nikon SB-800 strobes. Nikon makes a series of strobes that can be operated remotely from the camera without wires or radio links. These are extremely convenient to use. I usually just program each strobe for remote operation and then tell the camera to use TTL (through the lens) metering and how bright to make each strobe. 90% of the time I get a perfect exposure on the first try. On those rare times the exposure needs adjustment I simply tell the camera to make each strobe brighter or darker. Canon cameras have a similar system.

These strobes are small and use four AA batteries. There are models SB-400, SB-600, SB-800, and shortly after I bought my second SB-800, Nikon came out with the SB-900. Each model adds a few extra bells and whistles and delivers more illuminating power. The 800's are remarkably powerful and the 900's are about twice as powerful as that. Below is a site plan of a house that is about 150 feet long. It shows the locations of my camera, my two SB-800 strobes and a borrowed SB-900 strobe. Each is located 50 – 70 feet from the house.



The photo below was taken just to see if I could do it. I took one shot with just my two strobes. My friend came to find me and when he saw what I was doing offered the use of his SB-900 strobe. The first shot with all three strobes had the right hand SB-800 in the shot. For the final attempt (shown below) the offending SB-800 was moved closer to the tree. Running around in a strange yard, in the dark, trying something I've never done

before; I got a fairly good shot with that third try. Even with an 11mm ultra wide angle lens on the camera and with the camera as far away from the house as I could get one of the garages would not fit in the frame. Yet the three strobes lit the entire house. Some post processing was performed in Photoshop to refine the exposure, but the biggest touch ups were to remove the shadow of the wide-angle lens from the lawn and the bright spots on the lawn from the strobes.



In the past, I used strobes only as a last resort and hated it even then. Modern strobes are easy to use and can do wondrous things for your photographs.

Earlier that evening inside this same house I took another photograph of a large porcelain unicorn using a single remotely controlled SB-800 strobe. This shot tied in with the others not only



because of the same location, but because of the strobe. The unicorn is about 30" tall on a table about 20" tall. By aiming the strobe directly at the unicorn I got harsh shadows on the wall; but avoided any color shift that would have been created by bouncing the light off of the beige paint. With the window, backpack and other items in the background I wasn't worried about the horrible shadows caused by the single strobe held high in my left hand, because the shot would be cropped and all of the offending shadows and objects would be removed by replacing the background.



A new dark blue (blue is the complementary color of cream) was created and placed on a layer below the unicorn. However rather than cut or delete the offending objects surrounding the unicorn; a layer mask was created. This was done by using

assorted selection tools to trace the outline of the unicorn and then clicking on the add layer mask icon at the bottom of Photoshop's Layers display. This causes the selected area to be displayed to the right of the unicorn layer as shown here. The penalty for doing this is that the file size is made slightly larger. However, the benefits are well worth this extra size! The black areas of the layer (all that offending junk we don't want in the background) are made transparent so the new background below shows through. So far, the result is pretty much the same as if we had simply deleted the offending parts from the unicorn layer.



But we can apply a Gaussian blur of two to four pixels width to the mask. This is equivalent to using a feather when creating the selection (if your program allow it) and that ugly cut out with kid's scissors appearance is avoided. However, we now have several new options available. The Brush tool can be used to easily and precisely touch up any flaws that may be discovered in the original selection. Also by applying a gamma adjustment to the layer mask the entire selection can easily be increased or decreased by a few pixels to remove those unsightly tell tale blemishes that almost always show up around a selection. Also, you can change the amount of feathering later if you choose. More Gaussian blur increases the feather while more contrast reduces the feather. The level and ease of control with this technique is truly amazing.

At the March Meeting

Some of our members got new state-of-the-art cameras for Christmas and have now had a couple of months to get used to them. PC Q&A

One of the early and interesting questions during the February PC Q&A SIG concerned e-readers, or ereaders, or eReaders. Dennis Martin asked if e-readers could read PDF files. My response was that inexpensive models of the Kindle (now \$79) and the Nook could not. Between now and then I discovered that knowledge was out of date and that the latest versions of those devices have the native capability to deal with PDF files. Turns out that a lot more books are made available in electronic form



using the PDF format than I thought, before I started doing a little research on the subject. So if you're reading this Dennis, turns out I was at least partially wrong.

The first Kindle readers used the black and white E ink display technology also referred to as EPD or Electronic Paper Display. An OK explanation of the technology can be seen here: <http://www.eink.com/technology.html>. There are a number of things that are appealing about electronic paper displays. It is a reflective technology as opposed to a backlit technology which means that it can look better in bright light as opposed to being washed out the way an LCD screen is. Because of the way it works, it requires an extremely small amount of power to function. Instead of the battery life of the unit being measured in hours, it is measured in days and weeks. There is now a color version of the technology available, although it is not widespread yet.

In the last two or three years, eBooks and their readers have exploded in popularity. With, seemingly, everybody and his uncle trying to get into the e-reader/tablet business, the competition has helped to reduce the price of the units significantly while at the same time expanding their capabilities. For instance, the Barnes and Noble Nook has evolved into the Nook tablet. Except for the artificial constraints that Barnes and Noble have imposed on it, the hardware is capable of going toe to toe with a number of other tablets that costs quite a bit more. Some people have "rooted" the Barnes and Noble Nook tablet to uninstall the Barnes and Noble firmware and installed a customized but generic version of the android operating system. If you are enough of a geek to follow the online instructions for making this conversion, you end up with a full-blown color tablet for a very attractive price.

One member complained about having to pay for each of the books he downloaded to his reader and the lack of downloadable books for his reader that were free. Specifically, he complained that every site that he had gone to, to download a book he thought was free, a little window will pop up asking him how he wanted to pay for the book. He challenged me to find a site where I could download a book without having that happen. I was tempted to ask if he wanted to make a wager on it, as I knew it would be a sucker bet. To illustrate my point, I did a Google search on "free e-book downloads" and got about 292,000 results. I did a Google search on "free ebook downloads" and got about 1,080,000 results. In addition, I happen to know that the Baen.com website offers quite a few e-books in their free library. If you happen to be a science fiction fan, there is a lot of very good reading available there for free. But going back to the Google search on "free ebook downloads," the third item down on the list is "Project Gutenberg - free ebooks" www.gutenberg.org. If you go to that site, you can click your way through to this page:

Linux Desktop & Administrator

We started our meeting with an assortment of various discussion topics etc. I reported that on Jan 25, 2012, Spain had ordered the installation of the Linux Debian Distribution to be installed on 40,000 PC's in government offices, replacing all other operating systems currently in place. This was due to the country's effort to cut back on expenses and reduce the cost of proprietary operating systems and proprietary application software. But, what was more significant was the choice of the Linux Distribution...Debian. The Debian Linux Distribution is one of the oldest and possibly "the" oldest contributory systems in the open source movement. The Debian Distro is maintained by thousands (approx.) of individuals and groups of supporters. Many more popular Linux Distros are known as Derivatives of the Debian OS because they (other Distro OS's) can freely obtain and can freely use software developed by the various Debian teams. There are a dozens or so of these Debian Derivatives such as Ubuntu, Linux Mint, Dream Linux, and others. The reason that the Debian OS has been slow to catch on with the basic "Newbie" desktop users is that as a Developer OS using Debian required a lot of Administrative skills and Linux Programming knowledge and experience, whereas the derivative OS's made a point of simplifying the installation and Graphical User Interface (GUI) for the less technical end user... e.g./i.e. "The don't have a clue group." This has all been slowly changing and the Debian OS has been made much easier to setup and use. As mentioned earlier, the Spanish acceptance of the Debian OS for general use by government offices is the first major acknowledgment of this advancement of the Debian System on such a wide scale that I am aware of.



We also briefly discussed the upcoming availability of the Version 12.04 Ubuntu release anticipating the newer GUI interfaces of Unity, Classic Gnome, Gnome Shell, and the latest Gnome 3.4 GUI. All of this has created a great deal of confusion among many of the historic users of the Gnome GUI products. I will try to give a description of the term "Gnome Shell" as it differs from and is compared to the Gnome GUI Desktop in up coming meetings.

We continued in our search for Open CAD. A computer-aided design product. But, we were unsuccessful in doing so in Debian 6.0.3, or Redhat 16, or Ubuntu Versions 10.4, 10.10 or 11.4. We will keep trying to download, install and experiment with this product in future group meetings.

A short and minor presentation, introduction, and demonstration was done of the new *Open Shot Video Editor*. We went to the Internet and copied a sample video. Then we loaded this into the Open Shot Video Editor application window. By using some of the GUI functions we were able to cut and chop up the video and create a new video image. We then saved and played

this modified new copy. There are a great many things that can be done with Open Shot, of which we did just several. We will continue experimenting with this product in future meetings and attempt to master much of its capability.

Part of our meeting consisted of presenting and reviewing the GNU Info Coreutils (Core Utilities) package list. This is a list of Terminal Window, Linux Command Line functions. These are shown in a related list by category such as disk usage, file functions, directory functions, network functions, date and time functions, printing functions, and many others. It has been requested by several members attending that we expand this list to include several of these command line functions and examples at future meetings on a regular basis. This would be something like a Cheat Sheet Review. Which I will attempt to do.


We discussed, in short, why there is no decimal “as in base 10” arithmetic in the GNU C computer language. The C language does “binary integer” and “real floating point binary” math. But there is no real “base 10” standard numbering and data representation facility in the C language. This, of course, is a major road block for all business applications where dollars and cents are accurately required to be stated with 100 percent precision. IBM has developed an add-on package library called “libdecnumber” for real whole numbers. This package inclusion into the basic C language allows for reliable dollars and cents calculations in business and financial applications. We will be discussing this at more length in future meetings. Also, members have requested some examples of C language compiler code to be demonstrated, which will be on the agenda for our next meeting. Provided, of course, that: “it don't rain too hard too long and the creek don't rise.”

They were presented by guest presenter, Krish Krishnamurthy, from Siemens and Toastmasters. We also spent time viewing a video on “You-Tube” taken by Ben Lochtenbergh, NOCCC Director and SIG leader for the Mobile Computing SIG at 10:30, Room 109.

At the March 4th SIG, we will spend time looking at the various applications on the Smart phone and also how to upload, download to and from You Tube. We encourage each attendee to bring his/her various devices (laptops, iPods, iPads, androids, etc. and practice or demonstrate with us.



I immediately replied: "No thanks." I was content with the devices I possess, but, then I thought: "It would be a nice thing to participate in such a deal (**whichever way it goes**) and share that with our club members. I better hurry." So, I clicked on the link that came with the text message. This started a survey with 12 questions. Each question was informative and very well presented. I had to enlarge and scroll the text a few time, because I was using a small screen, but I answered all 12 questions. Then it passed me to an **auto insurance** website. It wanted me to enter the same contact information I just entered. I became suspicious. I saw no confirmation from them having received my 12 answers in good condition. However, I pushed on to see what's next. They asked me to select from several car insurance companies. I selected Geico. They wanted me to enter the same contact information a third time. **That was it for me!** I closed the session. Only a few minutes after that I received a telephone call on my other phone (land line) from 21st Century Insurance. It was 35 minutes before I had to leave the house to go to the monthly NOCCC board meeting. I wanted to watch the news (live) and eat dinner. So I told the insurance guy: "This is not a good time." I agreed tomorrow would be a better time. Sure enough he called back the next morning. I had a conversation with the salesman; the best he could offer is to have me pay 50% over what I'm currently paying. He said his deal is: "**A win-win situation.**" I said: "I'll pass on that opportunity." We remained polite until the end of the call and thanked each other for our time. I learned something about insurance.

What does this have to do with Apple? I'm still working on that! I have this feeling that something is not right with these sales schemes, but people, including myself, sometimes can't resist. Someone famously wrote a long time ago: "There is always another sucker born." Moral of the story: **Don't let it be you!** I made a number of mistakes, the first: responding to an unsolicited text message from outside my circles of friends.



An uplifting story: One of our members is in **danger of becoming a geek!** She has been making remarkable improvements in her quest to master computer technology. She makes valuable comments during the SIGs. Did she see: "Triumph of the Nerds?"

Let me explain an important point. During her 9:00 "Come, Care, and Share SIG," I demonstrated a number of things about a 2 minute video that I uploaded to YouTube a few weeks earlier. One of the demonstrations was how easy it is to change a video's Privacy from Public to Unlisted or Private. See illustration. Before I changed it, I had all attendees with their devices search, find, and play the video. After that I switched

The February meeting was less well attended. The themes were Government shutting down a website, petition to Congress about privacy, and the best 75 Apps. We had a few new faces and some regulars returned, perhaps due to Jim having to cancel his 10:30 SIG, because he all of a sudden had to do the 2 PM Main Meeting presentation. He made an excellent choice: "Google Docs."

Our presentation had 16 PowerPoint slides, 20 were emailed to members, so they can preview the meeting. I feel good about following the slides and ending at exactly 12 noon. However, people lingered for another 15-30 minutes, and Steven Breitbart showed his new Kindle device. We now have 24 devices in our database. Topics were the new **Android 4.0 Ice Cream Sandwich** (ICS) version on my Motorola XOOM tablet. It looks very nice and the upgrade is not overwhelming. Next, I want ICS on my Motorola DROID 2 Smartphone, but I must wait for the Verizon programmers to make the necessary program changes to their adaptations. There is pressure on Verizon to accomplish this; are they willing to pay the salaries to do this or will they rather sell new devices?

We looked at a list of 21 Apps that I selected from the 75 Apps, supposedly the best of the 400,000 Android Apps now available. Not all are free, but most were. We can both be shopping at the same time and update our shopping lists as we go, thus avoiding duplicated purchases. It now includes a way to coordinate our dinner plans (I messed up a few times). Also, I shared four problems I found with the OurGroceries App and gave two solutions.

Did you read that sometime this year **Smartphones will outnumber traditional phones**?

Next month I will demonstrate some of the new features of ICS. I'm specifically interested in the face recognition logon feature for my XOOM. I also would like to explore *my* question: **"Could a new model automobile be included in the database as a Mobile Computing device?"** Would an NOCCC member be so kind to test drive (or buy) one such car for consideration and report the specifications to our Mobile Computing SIG? ☺

Last, but not least, it was discussed and agreed to that the MC SIG database should include **a favorite App of each SIG member**. For example, Steven Breitbart has an App on his iPod Touch that, when I saw it, looked very inspiring to me. I would never think about looking for such an App, but could be wiser after being able to read about it. At this moment, I forget what this App was called or used for. Shortcomings like this point to the usefulness of having this information in a database. Also, Dr. Pat has an App in mind. I visualize them (and others) doing presentations on their favorite App. When we have a number of Apps documented, I'll email the information to all members.



Meeting Information — The NOCCC meeting is held at Chapman University, in the Hashinger Science Center and Irvine Hall, near the northwest corner of N. Center St. and E. Palm Ave.

Parking Information - Chapman University's main parking lot is the underground Lastinger Parking Structure under Wilson field on the north side of the campus. Enter from Walnut Avenue, just east of Glassell Street. Parking is not free on Sunday, even if the gate is up. **However, the permit vending machine is about 100 feet south of the entry area. There are other machines elsewhere in the lot.** Find one, buy a permit, and put it on your dashboard. Do not park in any other lot, in a reserved space, or back into a space.

Free street parking also is available on the campus-side of the streets only. Parking in front of any residential housing will result in an expensive parking ticket. A City of Orange public parking lot, located on the southwest corner of E. Maple and N. Orange, is also free and only 2 blocks from the meeting.
